

COMPETITION TERMS & CONDITIONS:

1. Competition commences 12:00, Australian EST, Monday, December 16, 2019.
2. Entries close at 23:59 Australian EST, Monday, March 23, 2020.
3. There are five (5) individual games - all single player.
4. Each game can be played multiple times during the competition period.
5. There is no cost to enter and all games are free to play.
6. The competition will be open to residents of Australia and New Zealand from the age of twelve (12). Minors entering must receive permission from their parent/s or guardian/s.
